

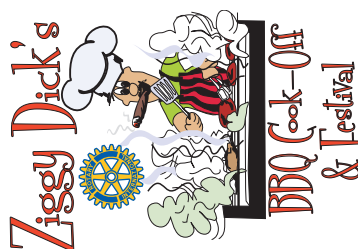


- This is going to be an exciting Bar-B-Que Competition and Festival.

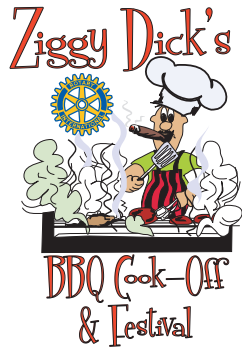

A quiet time will be in effect from 11:00 PM on the night prior to the contest judging, remaining in effect until sunrise on the following day. Failure to observe this quiet time may subject the offender(s) to removal from the contest site.

Rules & Regulations

1. Arrival/Setup begins on Friday, January 6th, starting at 8:00 am .
2. Cook sites are 20 x 40+ and they will be assigned on a first come, first served basis. No site will be reserved until payment is received.
3. Entry fees must be received no later than December 20, 2011. Entry fees must accompany registration form and are **NON-REFUNDABLE**.
4. One 20# bag of ice is complimentary each day. Additional 20# bags are \$4.00 each. Ice will be delivered to cook sites.
5. Beer will be sold on site. No glass containers allowed.
6. All cook sites must have a current fire extinguisher.
7. Electric connection free for cook teams kitchen only.
8. Teams that are vending are not permitted to sell bottled water or any other cold beverages.
9. Meat inspection begins at Noon on Friday.
10. Any tenting or tarping must display manufacturers fire-resistant labeling.
